

## Staff information sheet

**Research project:** Improving the environment for staff and patients

**Brief summary:** Our Trust is working with University of Southampton to identify ways that we can improve the environment of three of our wards for our staff and patients.

**What is involved?:** We will be installing a number of sensors that will measure and monitor a series of environmental factors for 9 months to cover summer, winter and spring conditions, including:



Temperature and relative humidity sensors will be placed near our patient's beds and on the ceiling heating panels.



Movement sensors will be placed on our patient's beds to check how much rest our patients are getting and on the windows to check the levels of natural ventilation in the rooms. Please note: it is important that beds are **not moved** during the research project.



Carbon dioxide (CO<sub>2</sub>) monitors will be placed on the benches in each of the 4 bed wards. Please note: It is really important that these monitors are **not unplugged** as we will lose any data gathered.



Noise level monitors will be placed on the benches in each of the 4 bed wards. These monitors **do not** record voices they only record the number of times that noise event occurs above a certain decibel. Like the CO<sub>2</sub> monitor: It is really important that these monitors are **not unplugged** as we will lose any data gathered.

**What will you have to do?** As part of the project we are asking all our nursing staff on these wards to each complete a weekly comfort survey. The survey should take no more than 5 minutes to complete but will provide us with invaluable information about how you feel. The surveys will be anonymous and we would appreciate your honest response.
