You are being invited to take part in the above research study. To help you decide whether you would like to take part or not, it is important that you understand why the research is being done and what it will involve. Please read the information below carefully and ask questions if anything is not clear or you would like more information before you decide to take part in this research. You may like to discuss it with others, but it is up to you to decide whether or not to take part. If you are happy to participate you will be asked to confirm your consent before participating.

What is the research about?

This research is being undertaken by a student working towards a PhD. The project aims to explore pig care in different spatial contexts. This research is funded by the Economic and Social Research Council's South Coast Doctoral Training Partnership.

Why have I been asked to participate?

You are being invited to participate in this study due to your experience of caring for pigs in animal research facilities.

What will happen to me if I take part?

Those who wish to participate in the research can do so by taking part in an interview and/or being 'shadowed' by the researcher whilst undertaking their normal work duties. Participants will be able to choose one or both options.

Should you decide to take part in an interview, you will be invited to select an appropriate date and time for your interview. Interviews will either take place in person at your place of work or over the phone, please let the researcher know if you have a preference and this will be accommodated for where possible. The interview itself is expected to last roughly 1 hour and will be audio recorded for transcription and analysis purposes.



The interview aims to be similar to an informal conversation. Before your interview, the researcher will provide you with a copy of the 'interview guide' which will outline the topics to be discussed. The interviewer will ask some pre-established questions based on these topics, however, may ask you to elaborate on certain topics where necessary. During the interview, if you are uncomfortable at any point, you are able to ask to move on from a topic or to terminate the interview.

Should you decide to be shadowed, the researcher will accompany you whilst you are interacting with pigs as part of your normal job. The researcher will observe you and may take notes (most likely during a morning/afternoon at a day and time to be agreed with you). Whilst you may be asked some questions while being shadowed, the researcher will aim to cause as little disruption to your work as possible. Where appropriate, some conversations you have with the researcher may be audio recorded for transcription and analysis purposes. However, you will be asked for verbal consent prior to recording and are under no obligation to be recorded. You can withdraw from shadowing at any point.

Are there any benefits in my taking part?

There are unlikely to be any direct benefits to you as a participant in this study. However, the study aims to improve our current understanding of the lives of pigs within the animal research context.

Are there any risks involved?

This is a low-risk study. You may be asked to recall potentially distressing experiences (for instance, regarding sick or injured animals). Where this is the case, every effort will be made by the researcher to approach these topics in a sensitive manner and to minimise the possibility of psychological discomfort or distress to you as a participant. You will be reminded that you are able to move on to another topic, to take a break or to terminate the interview at any point should you desire.

What data will be collected?

Audio recordings will be transcribed shortly after the interview/shadowing takes place. Audio recordings and transcripts will be stored on a password protected device and account with your name. The following section outlines who will have access to your data, how it will be kept secure and how long it will be kept.

Will my participation be confidential?

Your participation and the information we collect about you during the course of the research will be kept strictly confidential. Pseudonyms will be used to keep your identity anonymous in the research outputs.



Only members of the research team (such as the researcher and project supervisor) and responsible members of the University of Southampton may be given access to data about you for monitoring purposes and/or to carry out an audit of the study to ensure that the research is complying with applicable regulations. Individuals from regulatory authorities (people who check that we are carrying out the study correctly) may require access to your data. All of these people have a duty to keep your information, as a research participant, strictly confidential.

Any hard copies of signed consent forms will be scanned electronically and destroyed as soon as possible to be stored on a password protected device and account. Your contact details (such as your email address or phone number, which may have been used to invite you to the study initially) will also be secured on a password protected device and will not be shared beyond the research team. Uou may request for your contact details to be removed from the researcher's record at any time. You can do this by contacting Kate Goldie – kg5q14@soton.ac.uk

Recordings of your interview will be transcribed as soon as possible after interview. Once transcripts are created, original audio and video recordings will be destroyed. Interview transcripts will be deposited in the University's institutional repository, in line with the University's Open Access Policy. These transcripts will not contain identifiable information about you. To reduce privacy risks, any reference to your interview/audio recorded data in outputs of this research will only include a brief description of you (e.g. pseudonym/animal technician/gender identity) and will not include your real name. Only the research team will have access to identifiable data linked to you.

Do I have to take part?

No, it is entirely up to you to decide whether or not to take part. If you decide you want to take part, you will need to verbally consent to participation prior to starting the interview to show you have agreed to take part.

What happens if I change my mind?

You have the right to change your mind and withdraw at any time without giving a reason and without your participant rights being affected. Please email the researcher, Kate Goldie, if you would like to withdraw at kg5g14@soton.ac.uk.

What will happen to the results of the research?

Your personal details will remain strictly confidential. Research findings made available in any outputs of this project will not include information that can directly identify you. Outputs of this project may include written reports, articles published in academic journals or conference presentations.



Your name, the name of the organisation you represent, and your contact details will not be published in any outputs of this research. Direct quotes from interview transcripts may be used.

Every effort will be made to prevent the research data being linked to you, however, in some circumstances it may not be possible to guarantee this. For instance, the research may reference some of your experiences that may be unique to you. In this instance, the researcher will ensure details are kept as brief as possible (e.g., no real names or locations will be used).

In line with the university open access policy, research work submitted as a thesis for a higher degree as set out in the University's Higher Degree Regulations must be deposited and made publicly available in the University's institutional repository. This will not contain any identifiable information about you.

Any personal data we collect in this study will be used only for the purposes of carrying out our research and will be handled according to the University's policies in line with data protection law. If any personal data is used from which you can be identified directly, it will not be disclosed to anyone else without your consent unless the University of Southampton is required by law to disclose it.
